

TERMS AND CONDITIONS OF THE PRIMAVERA A CASA TEVA PROMOTION

1. PROMOTION ENTRY REQUIREMENTS

All persons over the age of 18 may participate as long as they correctly fill out the form that Primavera Sound will make available.
